



Sino-Swedish Colloquium on Global Sustainability Governance

中瑞全球可持续治理研讨会

18-19 March 三月 2024 ● 武汉大学 Wuhan University

Five decades after the UN Stockholm Conference on the Human Environment that marketed the beginning of global environmental governance, the world, with mounting geopolitical tensions, has been becoming increasingly divided and polarized. However, this polarized world, as threatened by the "triple planetary crisis" – climate change, pollutions, and biodiversity loss, is now struggling with achieving the 2030 Sustainable Development Goals (SDGs), which calls for more solid joint efforts and collective actions including the indispensable role of both Sweden and China.

Particularly, climate change, despite posing a crucial collective challenge, also offers a pivotal opportunity for a rejuvenated momentum of global sustainability governance in this polarized world. Moreover, operational standards in industrial and commercial activities as well as corporate governance models are also expected to be in line with measurable sustainability targets. New concepts and governance tools such as "greening global supply chains" and "Environment, Social, and Governance (ESG)" are increasingly reshaping a new horizon for sustainability governance towards climate neutrality in this polarized world.

Facing the urgent call for global sustainability governance towards climate neutrality, all stakeholders should work hands in hands, including both China and Sweden, both scholars and policy makers, both academia and private sectors. Against this background, scholarly communications and academic exchanges focusing on the nexus of global governance, sustainable development, and climate neutrality between Chinese and Swedish actors through this Sino-Swedish Colloquium might have the potential of sending a strong cooperative signal to the polarized world in support of a harmonized global sustainability governance towards climate neutrality that we can eventually be proud of.

Jonas Ebbesson is Professor of Environmental Law, former Dean of the Faculty of Law, and Director of Stockholm Environmental Law and Policy Centre, at Stockholm University. He was Chair of the Aarhus Convention Compliance Committee 2011-2021. He has written substantially about transboundary dimensions of environmental law, including on participatory rights and human rights; corporate responsibility; environmental justice; climate change law; and law in relation to social-ecological resilience, planetary boundaries, the Anthropocene and the UN sustainable development goals. He has been consultant or expert for governmental and intergovernmental bodies, and for environmental and development assistance NGOs, law firms; and legal counsel before Swedish courts and the European Court of Human Rights on matters relating to the environment and health.



Jonas Ebbesson 是斯德哥尔摩大学环境法教授、法学院前院长以及斯德哥尔摩环境法与政策中心主任。他在 2011 年至 2021 年间担任奥胡斯公约遵约委员会主席。他在跨界环境法的多个领域撰写了大量著作,包括环境参与权利和人权;企业责任;环境正义;气候变化法;以及与社会–生态韧性、行星边界、人类世以及联合国可持续发展目标相关的法律。他曾作为顾问或专家为政府和国际机构、环境与发展援助非政府组织、律师事务所提供服务;并作为法律顾问协助瑞典法院和欧洲人权法院处理与环境和健康相关的事务。





Prof. Karin Bäckstrand

Karin Bäckstrand is a Professor in Environmental Social Science at Stockholm University and an internationally leading scholar in global environmental politics, national and EU's climate policy and sustainable development governance. Her research interests concern the legitimacy and effectiveness of environmental governance, the politics of expertise and the role of non-state actors. Her latest forthcoming book is *The Politics and Governance of De-carbonization*. The Interplay between State and Non-state actors in the Sweden (co-edited with Marquardt, Nasiritousi & Widerberg, Cambridge University Press, 2024). Karin Bäckstrand is a previous member of the Swedish Climate Policy Council (2018-2022).

Dr. Meng Zhang is currently working as a Postdoc Fellow for climate law and policy at the Department of Business Law, School of Economics and Management (LUSEM), Lund University (Sweden). Dr. Zhang's research domain embraces international environmental law, EU environmental and climate law/policy, Chinese environmental and climate law/policy, and comparative environmental and climate law. He obtained his PhD degree (Doctor in Law) at Ghent University (Belgium, 2021). In addition, Dr. Zhang also works as an affiliated researcher for human rights and climate change at Raoul Wallenberg Institute (RWI) of Human Rights and Humanitarian Law (Sweden); a guest lecturer of the EU Jean Monnet



Module(EUIndoPac): the EU and the Indo-Pacific region (UCLouvain); and a National Rapporteur in the Climate Litigation Initiative (C2LI) led by the Strathclyde Centre for Environmental Law and Governance (UK).

Prof. Emily Boyd

Emily Boyd is Professor in sustainability studies and a leading social scientist with a specialist focus on environment and climate change. Her unique focus has been on the interdisciplinary nexus of poverty, livelihoods and resilience in relation to global environmental change, focusing on issues pertaining to cities, sustainable land use, water and deforestation in Africa, Latin America, South-East Asia and Europe. Her work has been published across the social and sustainability sciences with notable publications on resilience, adaptation and the politics and practice of community participation in the new carbon economy.

His research focuses on the constitutional development in the EU, as well as the EU internal market and competition policy, in particular state monopolies, public procurement and state aid. Hettne has recently focused on issues relating to the sustainable development of the internal market and the greening of world trade.

Christer Ljungwall is associate professor at University of Gothenburg School of Business, Economics and Law. He is a renowned economist and expert in economic development, trade and innovation. He has held several senior positions within academia, international organisations and as a diplomat. Amongst other appointments, he has been professor at PKU-HSBC Business School in China, researcher at Peking University main campus, Senior Economist at the Asian Development Bank, Head of Office of Science and Innovation at the Swedish Embassy in Beijing.

Dr. Andreas Inghammar is the Pro Dean of Lund University School of Economics and Management, and an Associate Professor in Business Law. He holds a LLD from Lund University and has been a visiting professor in both Italy (2018) and Cambodia (2015-2016). Inghammar research has primarily focused international and comparative labour market regulations, which has established him as a well-known academic scholar and the Swedish representative (National Expert) for the EU Commission funded European Labour Law Network. In parallel to his academic career, Inghammar has been a co-founder and served as inhouse council and at board level positions in the pharmaceutical industry, working with corporate finance, licensing and market communications.




